This report is provided to fulfill the State Board of Education's obligation pursuant to N.C.G.S. Section 115C-76.70(b) and includes information required to be submitted to the Joint Legislative Education Oversight Committee and Joint Legislative Commission on Governmental Operations by November 15 of each year. Based on SBE policy Parent's Guide to Student Achievement (PRNT-002, Section 4), public school units submitted the following to the State Board of Education:

#### Compliance:

**98.4% of all PSUs assert that they are in compliance with Article 7B of Chapter 115C. (n=316)**

114 out of 115 LEAs asserted that all policies submitted are in compliance with Article 7B of Chapter 115C of the NC General Statutes and that, to the best of my knowledge, all information provided on this reporting form is accurate at the time of submission.

- Chapel Hill-Carrboro City Schools: CHCCS staff were provided additional guidance, grounded in a collaborative approach, emphasizing the importance of working together with students, staff, and families to promote the best interests of every child. We believe in the power of dialogue, education, and understanding to navigate the complexities of these changes, ensuring

that our schools remain supportive spaces for all, as reflected in the PBoR staff guidance linked below:

197 out of 201 Charter, Regional and Lab Schools asserted that all policies submitted are in compliance with Article 7B of Chapter 115C of the NC General Statutes and that, to the best of my knowledge, all information provided on this reporting form is accurate at the time of submission.

*Four other PSUs asserted that they are not in full compliance.*

- Durham Charter School: The school failed to link to the school policy on Parental rights the Board approved 9/9/23.
- Northeast Academy for Aerospace and Advanced Technologies: We did not have a current PGSA on the website 23-24. It was outlined in the policy but not in parent-friendly terms. - RISE Charter School: We need to approve of our Parent Guide to Student Engagement (10/25).
- Uwharrie Charter Academy: We are currently updating our webpage and will be working on the policies. With that being said, we do have on our webpage the Bill for our parents to review.
