SUBJECT:

2015-16 Allocation for Repair and Renovations

In the 2015 Session (S.L. 2015-241), the legislature authorized the allocation of \$150,000,000 to fund the Statewide Reserve for Repairs and Renovations Account. The legislature allocated one-third (or \$50,000,000) of this Reserve to the Board of Governors of The University of North Carolina and directed the Board of Governors report to the Joint Legislative Committee on Governmental Operations on the allocation of these funds.

The Office of State Budget and Management released the funds to the Board of Governors in December 2015. At its December 10, 2015 meeting, the Board of Governors allocated its funding in accordance with the guidelines developed in The University of North Carolina Funding Allocation Model for the Reserve for Repairs and Renovations.

The model allows the Board of Governors to consider allocations for high priority projects prior to applying the formula and directs that the formula be updated with the most recent institutional information on mission, size, and condition of campus facilities, before it is used to calculate constituent university allocations. The Chancellor at each university then selects the specific projects to be completed within that allocation and the statutory requirements:

- 1. The funds will be used only for the following types of projects:
 - a. Roof repairs and replacements
 - b. Structural repairs
 - c. Repairs and renovations to meet Federal and State standards
 - d. Repairs to electrical, plumbing and heating, ventilating and airconditioning systems
 - e. Improvements to meet the requirements of the Americans with Disabilities Act (as amended)
 - f. Improvements to meet fire safety needs
 - g. Improvements to existing facilities for energy

- h. Improvements to remove asbestos, lead paint and other contaminants, including the removal and replacement of underground storage tanks
- i. Improvements and renovations to improve the use of existing space
- j. Historical restoration
- k. Improvements to roads, walks, drives, and utilities infrastructure
- 1. Drainage and landscape improvements
- 2. S.L. 2015-241 also requires that the Board of Governors shall negatively weight the availability of non-State resources and carryforward funds available for repair and renovations and shall include information about the manner in which this subsection was complied with in any report submitted pursuant to G.S. 143C-4-3(d):

The Board of Governors reviewed the UNC baseline R & R allocation formula with respect to the gross square footage, total non-state receipts, and carryforward funds for all UNC institutions. This review yielded a receipts-based model that reallocated baseline R & R funds from North Carolina State University and the University of North Carolina at Chapel Hill to all other UNC institutions.

The attached list of projects shows the Board of Governors allocations to each constituent university and the intended projects that will be funded from the available \$50,000,000. UNC institutions identified as 'pending' remain under process review and will be submitted at a later date.
