Re: 2015 Settlement Costs Report

This report contains the annual costs associated with the defense or settlement of lawsuits filed by current or former state employees and applicants for state employment. Pursuant to G.S. 126-6.2(a), the head of each state agency, department, or institution employing state employees subject to the State Human Resources Act is required to report these costs to the Office of State Human Resources (OSHR) on an annual basis. OSHR compiles these agency reports and sends the information to the State Human Resources Commission (SHRC). Pursuant to G.S. 126-6.2(b), the SHRC is required to report annually on these costs by May 1st to the Joint Legislative Commission on Governmental Operations.

During 2015, 39 settlements were processed by OSHR with a total cost of \$1,450,380.69. The average cost per settlement was \$37,189.25.
