TOPICS REQUESTED BY SUBCOMMITTEE ON HURRICANE RESPONSE AND RECOVERY

- Funds are regulated by HUD's Disaster Recovery Grants Reporting system (DRGR)
 within the HUD-approved CDBG Action Plan and by the NC Financial System (NCFS)
- Moved all eligible, unobligated funds to HRP by Substantial Action Plan Amendments and sought additional funding from other sources
- Conducts regular budget reviews/reconciliations with NCDPS and OSBM; with 20+ audits(HUD, OIG, NC Auditor, others)
- Program consolidations and staff offboarding plan reduces 45 FTEs in August 2024, March, June, and September 2025.
- Funding uncertainty has slowed contract awards and Notices to Proceed(NTP.)
- The payment policy for contractors, vendors, and homeowner stipends is 30 days after approved. GCs were noticed in Q4 2024 that the pay period could be up to 60 days.
