RE: Request for consultation for Assisted Living Administrator Certification Renewal Fee

Dear Committee Members:

The N.C. Medical Care Commission is submitting this request for consultation on a proposed rule adoption to impose a fee for Assisted Living Administrator Certificate Renewal in accordance with N.C. Gen. Stat. §12-3.1 and §90-288.15A. The proposed rule, 10A NCAC 13F .1703, would define the processes used by the Adult Care Licensure Section of the Division of Health Service Regulation in the Department of Health and Human Services (DHSR/DHHS) for renewing administrator certificates. The proposed rule adoption will be published in the N.C. Register on September 15, 2016 and a copy of the proposed rule is enclosed.

Currently, there are no rules governing the Assisted Living Administrator Certification process required by N.C. Gen. Stat. §90 Article 20A, the Assisted Living Administrator Act, carried out by Adult Care Licensure Section of DHSR/DHHS that include the renewal fee. Historically, applicants have been charged \$30 to renew their Assisted Living Administrator Certificate every two years in accordance with N.C. Gen. Stat. §90-288.15A. No applicant has ever objected to paying this fee.

Amount of Current Fee/Amount of Proposed Fee/Statutory Authority for Fee

With no Assisted Living Administrator Certification renewal fee amount in current rule, there is a need to propose a rule defining the process used by the agency for administrator certification renewal that also includes collecting a renewal fee of \$30 in accordance with N.C. Gen. Stat. §90-288.15A.

Explanation of the Need for Fee

The Assisted Living Administrator Certification renewal fee is specifically provided for as part of the Assisted Living Administrator Act in N.C. Gen. Stat. §90-288.15A, Fees. To be an administrator of a licensed Adult Care Home (commonly known as Assisted Living facility) and to manage and operate the home, an applicant is issued an administrator certificate after successfully completing criteria outlined in N.C. Gen. Stat. §90-288.14, including an administrator-in-training program. The certificate expires on December 31 of the second year following issuance. All administrators who wish to renew their

certificates to be able to work in a licensed Adult Care Home as an Assisted Living Administrator must renew their certificate by submitting continuing education documentation, as defined in N.C. Gen. Stat. §90-288.15, and by submitting a fee, as defined in N.C. Gen. Stat. §90-288.15A. To cover the costs of enforcing the provisions of the statute for administrator certificate renewal, the Adult Care Licensure Section of DHSR/DHHS charges this fee. Putting the administrator certification renewal fee in the proposed rule adoption corrects a deficiency of not having this fee in current rule.
