FY 15 REPORT on Rural Division Grant Activity

and Policy Recommendations

#### GRANT AWARDS AND DISTRIBUTION OF AWARDS:

The attached documents summarize the following for the Building Reuse, Economic Infrastructure, CDBG-ED and Utility Fund grant programs within the Rural Division:

- An Excel spreadsheet displaying total number of grant awards made July 1, 2015 through June 30, 2016. Organized by program (Building Reuse, Economic Infrastructure, CDBG-ED, Utility Fund) and then by county. The excel sheet identifies the county, applicant, tier (at time of award), project business, requested amount, award amount, the number of jobs committed and award date.
- Maps of the geographical distribution of the awards by program.
- Map of the cumulative distribution of grant awards.

The Rural Infrastructure Authority (RIA) awarded these grants between July 1, 2015 and June 30, 2016.

#### **POLICY RECOMMENDATIONS:**

- 1. The Rural Infrastructure Authority, in FY15, determined we would establish wage and health standards as well as consideration for the State's development priority industry standard. We have successfully implemented that criteria and all Rural Grants (Building Reuse and Economic Infrastructure) are reviewed and considered according to those criteria. The Utility Fund and CDBG-ED have criteria as established in legislation.
- 2. Beginning in FY16, and as directed by the General Assembly, the RIA began granting Building Reuse funds and CDBG funds for Demolition grants to assist communities in reestablishing a viable site for business recruitment. These sites are blighted sites with available infrastructure in place making them good opportunities to recruit and locate capital investment.
- 3. In FY15, the Assistant Secretary engaged the Authority in discussions on how we can better inform local governments of available resources? How can the Division assist local government units in meeting the need for preliminary project planning to enable them to apply for grants? In what ways can we better evaluate the effectiveness of our grants into local communities? (NCGS 143B-472.128 (j) (5) (6) (7))
  - In FY16, in addition to various presentations made by the Assistant Secretary and her staff to local communities, the Department of Commerce, Secretary Skvarla and the Rural Division engaged in 21 presentations across the state from February 2016 through June 2016. More than 2,000 citizens attended these events including elected officials, local and state government employees and those in other fields of service. In these presentations, all Rural Division grant programs were identified and discussed.
- 4. In the attempt to better assist local government units in preliminary project planning, the existing community planners have reorganized their work and now function under the Main Street & Rural Planning Center. A major function of the planners is to assist local government units in planning activities that will enhance their opportunities to create economic advancement.






# Community Development Block Grant Awards Rural Infrastructure Authority




