Dear Mr. Krebs:

The Joint Legislative Commission on Governmental Operations: Subcommittee on Hurricane Response and Recovery requests your appearance to testify on Thursday, March 6, 2025, in the Legislative Building Auditorium. The hearing begins at 9:00 a.m.

Thank you for your attendance at the previous Subcommittee hearing, and we regret the short amount of time dedicated for your testimony. Therefore, as the Western North Carolina Recovery Advisor for the Governor's Office, the Subcommittee would like further information on the following topics:

- Describe the role and responsibilities of GROW NC and any lessons learned from prior iterations of recovery programs within North Carolina;
- Explain whether you have the authority to act on behalf of Governor Stein in all matters relating to your office;
- Share your current priorities for western North Carolina recovery;
- Share your plans for reporting program updates to the General Assembly, Governor Stein, and the people of North Carolina; and
- Other topics as appropriate.

Please read this letter carefully to ensure that you comply with all hearing requirements and that you understand your rights as a witness.

Each witness who is to appear before a subcommittee of the Joint Legislative Commission on Governmental Operations must file a written statement of proposed testimony. **This must be filed by 12:00 noon one week before your appearance. Failure to comply with this requirement may result in the exclusion of your written testimony from the hearing record and/or the barring of your oral presentation of the testimony.** Your oral testimony should not exceed fifteen minutes and should summarize your written remarks. Responses to questions at the hearing should be limited to no more than five minutes per response.

Further, a witness appearing before a subcommittee of the Joint Legislative Commission on Governmental Operations must include with their written testimony, a current resume summarizing education, experience, and affiliations pertinent to the subject matter of the hearing.

Witnesses at hearings may be accompanied by their own counsel to advise them concerning their constitutional rights, but accompanying counsel shall not directly respond to questions. The Subcommittee reserves the right to place any witness under oath. Finally, witnesses may obtain a transcript copy of their testimony given in open, public session, or in a closed session when authorized by the Subcommittee, or at any time when examined under oath.

To fully prepare for this hearing, your testimony must be submitted electronically in Microsoft Word (docx), Microsoft PowerPoint (pptx), or Adobe Acrobat (pdf) format to NCGAGovOps@ncleg.gov no later than **Thursday, February 27, 2025.** Accommodations for individuals with disabilities, including assistive listening systems, interpreters, and materials in alternate formats, may be arranged by contacting the staff member below in advance of the hearing.
