







- 12.25-hour shift model





State/Local Government Employment	Government agencies have labor contracts for offender to provide janitorial services and grounds keeping.
Work Release	Offenders nearing their release date and proven trustworthy for limited release can work for businesses in the community

DAC Institutions: Statewide Misdemeanant Confinement Program (SMCP)

- SMCP houses certain misdemeanants in local jails who receive a sentence greater than 90 days, and all offenders convicted of DWI
- All counties participate in SMCP as "sending" counties
- County jails with available space that house offenders from neighboring counties are "receiving counties"
- Counties are reimbursed by the SMCP fund
- SMCP funded at \$22.2m per year
 - Sheriff's Association receives \$1m/year for admin. of the program
 - DAC allowed to use \$225k for admin.
 - Up to \$500k may be used for inmate litter program



DAC Community Supervision by Fund: NGF FY 23-24



DAC: Community Supervision Vs. Prison

By design, **Structured Sentencing and the Justice Reinvestment Acts** created paths for **convictions of lesser offenses** to **serve sentences in the community** in lieu of prison



- 75,857 offenders under supervision as of January 31, 2025
- Offender Supervision \$9.36/day

NGF FY 2023-24: \$216m 2,414.5 FTE

- Nearly 1,600+ Probation and Parole Officers across the State supervise 70k + offenders
 - Place offenders into appropriate supervision levels through comprehensive risk and needs assessment
 - Counsel offenders
 - Make decisions regarding treatment for offenders
 - Respond to offender behavior and noncompliance

- Probation and Parole Officer (PPO) pay schedule established in FY 2021-22
- PPOs must have a bachelor's degree
- 8-weeks Basic Training before any shift work; 40 hours of annual inservice training
- 8-hour shift model with 4-12 evening shifts
- PPO Vacancy Rate: ~11%

DAC Community Supervision: General Supervision Authority

- Under the Justice Reinvestment Act, court can revoke probation for committing additional criminal offenses or absconding
- Court may impose a period of "confinement in response to violation" (CRV)
- Delegated authority allows PPOs to impose certain additional requirements without court involvement



DAC Community Supervision: Judicial Support

- Purpose: Get PPOs out of the courtroom
- Liaisons that process offenders from court to probation
 - Offender education
 - Assign offender to PPO
- Community service tracking and enforcement

DAC: Confinement in Response to Violation (CRV)

- CRV are behavior modification centers for probation violators
 - 90 days
 - 2 stays before revocation
- 2 Facilities
 - Robeson: I92 beds (M)
 - North Piedmont: 136 beds (F)
 - Burke CRV temporarily closed
- 2,084 revocations from CRV in CY 2024

DAC Health Services: Scope

Health Services provides constitutionally-consistent medical care to all offenders in custody from entry through release.

Services Provided:

- Routine outpatient and nursing care in facilities; inpatient care at Central Prison Hospital and NCCIW
- Behavioral and Psychiatric Services
- Alcohol and Chem. Dependency Treatments
- Dental
- Pharmacy




DAC Health Services by Fund, NGF Actual Expenditures FY 2023-24

DAC Health Services: Cost Increases

Multiple contributing factors to increases in health services costs include:


- National increasing costs of health care
- Offenders with a care deficit and with untreated **pre-existing conditions**
- Inmates seek health services resources for secondary gain
- More likely to have communicable diseases such as HIV/AIDS, hepatitis, and tuberculosis
- Mental health and substance abuse are more common among offender population
- Aging population

- Persistent high vacancy rates for nurses result in the use of contract/traveling nurses, which are more expensive on a per capita basis.
- Nurse positions make up 38% of all Health Services FTE.

DAC Health Services: Alcohol and Chem. Dependency Programming (ACDP)

- ACDP provides substance use disorder treatment, recovery and continuing care services in three ways
 - Community-based residential treatment programs for probationers and parolees
 - Prison-based Intermediate intensive outpatient treatment programs
 - Long-term prison-based intensive outpatient treatment programs
- Includes Drug Abuse & Alcoholism Rehabilitation Treatment (DART) Center for men and Black Mountain Treatment Center for women
- \$16m/year for all program expenditures




DAC Rehab & Reentry: Offender Education Attainment

DAC Rehab & Reentry: Treatment for Effective Community Supervision Programs (TECS)

- Treatment for Effective Community Supervision Program (TECS) was created under the Justice Reinvestment Act
- Series of contracts for community-based services focusing on evidence-based practices aimed at reducing recidivism
- 3 Core programs
 - Recidivism Reduction Services (RRS)
 - Transitional/Temporary Housing (TH)
 - Local Reentry Councils (LRC)



DAC Rehab & Reentry: TECS Programs

Recidivism Reduction Services

- Vendor-based social services
- Core services include:
 - Cognitive behavioral intervention
 - Booster sessions
 - Continuum of substance abuse service
- Largest TECS Program
- Performance-based contracts; \$3.8m/year in FY 22-23

- Structured, positive and safe environment for an interim period
- Vendors provide social support and program services in addition to housing
- Average length of stay: 49 days
- ADP: 137



- S.L. 2021-180 (select items)

 - Inmate Medical Budget Deficiencies: \$50m recurring
 - Prison Pharmacy Operating Costs: \$3.4m recurring
 - 32 Additional Community Corrections Positions: \$2.4m recurring
- S.L. 2023-134
 - TASER program support: \$1.5m recurring
 - Campbell University Second Chance Initiative: \$1m recurring

DAC: Key Takeaways



- I. DAC supervises more than 100 k offenders
- DAC represents ~50% of the JPS budget and ~60% of the FTE
- 3. Operating prisons most costly and labor intensive, but community supervision supervises twice the number of offenders with fewer personnel and resources
- 4. Offender healthcare continues to drive costs upward
- 5. Vacancy rates remain above 30% for Correctional Officers
