Contract award and design fee have been received as a lump sum cost, and the additional funding requested will meet these obligations.

The Old Heating Plant has been unoccupied for several years, and is in a dilapidated condition. The Old Film Library and the Oral Hygiene Building are used for storage, and are in poor condition. The square footage for each building is relatively small, making any attempt for renovation prohibitively expensive. After the demolition of these buildings the site would be restored to an appropriate level of landscaping.

In addition the project replaces the topping slab adjacent to electrical panels, and deteriorated curbing to prevent vehicles from running overboard.
то	DACS	Livestock Research Facility Renovations	41717-4X14	\$168,000.00	Provides funds for the renovation and upgrade of the Livestock Research Facilities to include improving electrical systems, structural repairs, replacement of roof material, replacing pens, gates, fences, food storage, repairing concrete floors and repairing animal waste storage pits in the following Stations (Counties): Cherry (Wayne), Mountain (Haywood) and Piedmont (Rowan).
