## LEGISLATIVE DIRECTIVE

Session Law 2024-57, Section 3J.17.(d) and Section 7.36.(b) directed the Executive Director of the Center for Safer Schools to establish the N.C. School Resource Officer and the N.C. School Safety Grant programs with the purpose of improving safety in public school units by providing grants for school resource officers, services for students in crisis, school safety training and safety equipment in schools.

Specific allocations for the 2024-25 school year include:

- \$33 million for School Resource Officers
- \$35 million for Services for Students in Crisis, School Safety Training and Safety Equipment in Schools (including \$5.2 million for the Artificial Intelligence Pilot Program)

This report will serve as the required reporting by the Executive Director of the Center for Safer Schools to the Joint Legislative Education Oversight Committee, the Joint Legislative Oversight Committee on Health and Human Services, the Joint Legislative Oversight Committee on Justice and Public Safety, the Joint Legislative Commission on Governmental Operations, the Senate Appropriations/Base Budget Committee, the House Committee on Appropriations and the Fiscal Research Division as indicated in Section 3J.17.(d) and Section 7.36.(m) of Session Law 2024-57.

- Identity of each entity that received a grant through the program.
- Amount of funding provided to each entity that received a grant.
- Use of funds by each entity that received a grant.
- Recommendations for the implementation of additional effective school safety measures.

## SCHOOL RESOURCE OFFICER GRANT DETAILS

For 2024-2025, the School Resource Officer Grant Program made available \$33 million earmarked for the hiring and training of school resource officers. In addition, legislation allows the Center for Safer Schools \$100,000 of this funding for Administrative Costs. These funds were available to district, charter and other independent public schools.

<b>Application Approvals</b>	The grants were evaluated and scored by the School Safety Grant Committee. Funding was disseminated to accommodate and fund as many PSUs as possible.

A total of 198 public school units submitted \$53.1 million in requests for School Resource Officers. The Center for Safer Schools was able to award a total of \$33 million to 198 PSUs.

Low-wealth PSUs were able to request \$44,000 per SRO, with a 4:1 local fund match. Non-low-wealth PSUs were able to request \$36,666 per SRO, with a 2:1 local fund match.

## SCHOOL SAFETY GRANT DETAILS

For 2024-2025, the School Safety Grant Program made available \$35 million for the purchase of Safety Equipment, Services for Students in Crisis and Training to Increase School Safety. These funds were available to district, charter and other independent public schools.

In addition, there was \$5.2 million earmarked for the Artificial Intelligence Pilot Program to legislatively designated PSUs.

<b>Application Approvals</b>	The grants were evaluated and scored by the School Safety Grant Committee. Funding was disseminated to accommodate and fund as many PSUs as possible.

Out of more than \$86.8 million in requests, 246 entities (PSUs and individual schools) were awarded a total of \$35 million, which includes the \$5.2 million awarded for the Artificial Intelligence Pilot Program.

Based on the amount requested last year, we enlisted a cap on the amount each PSU was able to request. Traditional PSUs were authorized to request up to \$500,000 for Equipment, \$350,000 for Services and \$350,000 for Training. Charter PSUs were authorized to request up to \$250,000 for Equipment, \$350,000 for Services and \$350,000 for Training. Services and Training amounts are legislatively mandated. The School Safety Grant has no matching funds requirement.

The Artificial Intelligence Pilot Program awardees were legislatively mandated and did not require any applications.

## **ANTICIPATED FUTURE NEEDS**

The amount requested for School Resource Officer funding increased from \$36 million in 2022-2023 to \$53 million in 2024-2025. The demand for SROs in the schools continues to grow. We were able to allot the recurring \$33 million for SROs this year, leaving \$20 million in requests unfunded.

The 2022-2023 School Safety Grant provided \$41.5 million for Safety Equipment, Services for Students in Crisis and Training to Increase School Safety.

The 2023-2024 School Safety Grant provided \$35 million for Safety Equipment, Services for Students in Crisis, Training to Increase School Safety and the Artificial Intelligence Pilot Program.

For 2024-2025, public school units requested over \$86.8 million in School Safety Grant funding, and \$35 million was awarded. This included \$5.2 million for the Artificial Intelligence Pilot Program.

There is a demonstrated interest by PSUs for additional funding for school safety initiatives. The requests continue to increase as school personnel receive training and increase their partnerships with law enforcement agencies. Law enforcement agencies can assist with vulnerability assessments, identifying safety concerns.

## **RECOMMENDATIONS**

The following changes would help improve the effectiveness of the School Resource Officer Grant and School Safety Grant programs in advancing the goal of strengthening school safety across the state:

- Permit carryforward of encumbered, unexpended funds for 90 days. This allows public school units to finish critical training over the summer; extend student-in-crisis services during the summer months; and complete procurement processes.
- Increase the amount of School Safety Grant recurring funding to accommodate the rising requests and demonstrated interest.
- Continue the lowered match requirement for low-wealth counties for the SRO Grant.
