AREA: Tract 1 -  $\pm 130$  acres

UNIT COST: Tract 1 - \$2,523/acre

CONSIDERATION: Tract 1 - \$328,000

COMMENTS: Plant Preserve Addition. Property proposed for acquisition is for the establishment of a new plant conservation preserve in McIntosh Bay. Acquisition of this property is critical to protect and enhance populations of imperiled and rare plant species and rare species of amphibians. Funding for this acquisition is provided by a grant from the Clean Water Management Trust Fund (\$236,356), a US Fish & Wildlife grant (\$37,379) and private donations totaling \$54,265.
