### Why Preserve Farms and Forests in North Carolina?

The NC ADFP Trust Fund Saves the Family Farm for Future Generations



-Agriculture and agribusiness is North Carolina's top industry, accounting for almost one-sixth of the state's economy and employees.

-Agriculture and agribusiness amounts for almost 17 percent, or \$87 billion, of the \$522 billion gross state product.

-Working lands provide fresh, local foods to North Carolina residents and quality products to the agriculture, forestry and fiber industries.

-Agriculture is a compatible industry with the military and military training, which is second in economic importance in the state at \$66 billion.

-Working lands provide scenic rural landscapes for tourism, the third largest economic sector in North Carolina.

-Farms and forests are critical in providing a healthy environment. Working lands are actively managed by farmers, providing key benefits like erosion control, carbon sequestration and provides waterway buffers.

-Cost of community services studies in the state show that agricultural lands use less tax dollars than are collected. Working lands are a net provider of local tax dollars.

### North Carolina Sentinel Landscape Committee

- In 2016, the federal government designated 33 North Carolina counties as a Sentinel Landscape. The Eastern North Carolina Sentinel Landscape is one of six Sentinel Landscapes designated by the U.S. Departments of Agriculture, Defense, and the Interior.

- North Carolina is the only state to have multiple military branches, military installations and counties named as part of the designation.

- Agriculture and the military are the top two economic sectors in North Carolina. The Eastern North Carolina Sentinel Landscape leverages partnerships between military installations, federal departments, state agencies, local governments and non-profit partners that support North Carolina's top two economic sectors.

- Pursuant to state law, the North Carolina Sentinel Landscape Committee will:

- Coordinate the overlapping priority areas in the vicinity of and where testing and training occur near or adjacent to major military installations, as that term is defined in G.S. 143-215.115, or other areas of strategic benefit to national defense.
- Assist landowners in improving their land to benefit their operations and enhance wildlife habitats while furthering the State's vested economic interest in preserving, maintaining, and sustaining land uses that are compatible with military activities at major military installations and National Guard facilities.
- Develop and implement programs and strategies that:
  - Protect working lands in the vicinity of and where testing and training occur near or adjacent to major military installations or other areas of strategic benefit to national defense,
  - o Address restrictions that inhibit military testing and training, and
  - Forestall incompatible development in the vicinity of and where testing and training occur near or adjacent to military installations or other areas of strategic benefit to national defense.

### **NC ADFP Trust Fund Military Projects**

- On December 15, 2017, the NC ADFP Trust Fund recorded the first two conservation easements in North Carolina using state and military funds. These farms are located in the military training airspace to the Dare County Range.

- There are 31,932 acres of farms and forests with conservation easement options in areas of military importance. These include 21,220 acres in the United States Air Force priority zones and 10,712 acres in the United States Marine Corps priority zones.

- The NC ADFP Trust Fund has cooperative agreements with the United States Air Force and United States Marine Corps to record more conservation easements on farms and forests in priority training areas.


- The NC ADFP Trust Fund has contracted for 2,037 acres of farms and forests using the awarded conservation easement funding of \$1,162,570 from the 2016 Southern Sentinel Landscapes Conservation project through the United States Department of Agriculture (USDA) Natural Resource Conservation Service (NRCS) Regional Conservation Partnership Program (RCPP).

- The state was awarded conservation easement funding of \$5,620,000 for the North Carolina Sentinel Landscapes High Priority Protect Program (NCSLHPPP) for 2018 through the USDA NRCS RCPP. The NC ADFP Trust Fund is currently working with military partners and willing landowners to determine priority parcels for the project.

### **Voluntary Agricultural Districts**

The Voluntary Agricultural Districts (VAD) program encourages the preservation and protection of farmland by allowing landowners to publicly recognize their farms. The VAD program is a county-level ordinance that establishes an Agricultural Advisory Board that provides a voice for farm, forestry and horticultural interests in local government. Farms enrolled in the VAD program may reduce the threat of nuisance conflicts, may allow for waivers for water and sewer assessment and may provide public hearings for proposed condemnations. Program provisions vary by county. Enhanced VAD (EVAD) member benefits are the same as VAD, plus: may receive up to 25% of its gross sales from the sale of nonfarm products and still qualify as a bona fide farm and are eligible to receive a higher percentage of cost share funds under the Agriculture Cost Share Program. The EVAD conservation agreement is irrevocable for 10 years. The conservation agreement is automatically renewed for three (3) years absent a written notice to the county revoking the conservation agreements. There are 89 counties with VAD programs.

### **Farmland Protection Plans**


Guiding Counties to a Viable Agricultural Future

Farmland Protection Plans are strategic proposals that define how to maintain a viable agricultural economy in a county.

These plans describe existing agricultural activity in a county, list challenges to continued family farming in the county, list opportunities for enhancing the local agricultural economy, create a schedule for implementing the plan and identify possible funding sources for long-term support of the plan.

Farmland Protection Plans are approved by the North Carolina Department of Agriculture and Consumer Services and endorsed by the county Board of Commissioners.

There are 60 counties in North Carolina with Farmland Protection Plans. Two counties are developing Farmland Protection Plans.





### North Carolina Beehive Grant Fund

- Eligibility:
  - Must be a North Carolina resident
  - Must be at least 18 years of age
  - Must be a Certified Beekeeper as determined by the North Carolina State Beekeepers Association at the time of filing the grant application
- Use of Grant Funding:
  - The purchase of a new hive for bees
  - The purchase of materials or supplies to be used for the construction of a new hive for bees
  - Grant funding allocations dependent upon documented expenditures of the grant's contracted items
  - Anticipated time for awarded grantees to redeem funding from the Beehive Grant Fund – February 1, 2018 - June 30, 2018
- Grant Funding Limits and Amounts per Selected Grantee:
  - \$200 limit per new hive
  - \$2,400 maximum grant allowance per selected grantee
- Grantee Commitments for receiving Beehive Grant Funding:
  - Grantee shall provide annual documentation of the ownership and appropriate maintenance of the beehive structure(s) for 5 years following receipt of grant funding
- Definitions:
  - New hive for bees a container for housing domesticated honeybees
  - *Materials or supplies* purchased construction items used exclusively for the building of a new hive for domesticated honeybees
