#### ITEM 15

Land Exchange. The University of North Carolina at Charlotte requests approval of an equal value land exchange between the State and The Foundation of the University of North Carolina at Charlotte, Inc. (Foundation). The State will convey to the Foundation a  $\pm 0.76$ -acre parcel adjacent to Foundation-owned property along North Tryon Street and Robert D. Snyder Road. In exchange, the Foundation will convey to the State a  $\pm 0.76$ -acre parcel at J. W. Clay Boulevard and North Tryon Street. The Foundation will utilize the property to build a full-service Marriott hotel/conference center adjacent to the Charlotte Area Transit System's light rail station. The hotel design will include a pedestrian plaza and walkway that will connect the campus to the light rail station.
