Housing Implementation Procurement

Worked with a team of procurement and legal professionals from DCR and Commerce to develop the RFP

The team considered lessons learned from NCORR, other states, and input from the General Assembly to design a procurement that prioritized:

- Urgency
- Quality
- Value

Evaluation committee was comprised entirely of members from Commerce and OSBM

Housing Implementation Procurement

To achieve these priorities, DCR established an evaluation strategy that emphasized experience with:

Quickly implementing CDBG-DR single-family housing programs of similar size

Launching large scale CDBG-DR housing programs

Closing out large scale CDBG-DR housing programs

Providing technology for CDBG-DR housing programs

Resumés with experience implementing CDBG-DR housing programs

References that would rehire the vendor

Outcome-based performance payments rather than time & materials fees
