Good evening Durwood,

Thank you for your email yesterday. And thank you especially for the opportunity to address the issue of local access to gas off the proposed Atlantic Coast Pipeline.

Secretary Copeland should expect to receive from David Fountain very soon a detailed description of how the company intends to use this new supply of gas to meet its projected growing demand for gas in Eastern North Carolina, both from existing customers as well as from those who will, because of ACP, have a greater chance of being reached by an expanded distribution system.

It is my understanding that because some of what Duke/PNG will share will include confidential business plans, it will not, in its entirety, be shared beyond government officials. However, I am very confident that what can be shared, at your convenience, will provide you the assurances you need to continue your strong advocacy in support of the project.

In broad terms, the ACP will initially be constructed with three interconnections to the PNG transmission and distribution system. Those interconnections are located near Smithfield, Fayetteville, and Pembroke; locations chosen by PNG as being the most important points for boosting their distribution network.

After ACP is operational in late 2019, should a large industrial customer seek gas directly from ACP in a location where a new tap and transmission line would be the best solution, ACP and the PNG, or another relevant local gas utility, would work with that customer to help them access gas directly from the line per the open access rules of the Federal Energy Regulatory Commission. These process are spelled out in the attached "tap policy" adopted by the ACP project in 2014.

You also mentioned the important priority of reaching more farming operations. We understand this imperative. As has been discuss with Mr. Wooten and his staff on several occasions, ACP will bring with it new opportunities for PNG to reach more operators. I will leave it to PNG to elaborate further on this opportunity, though during our last meeting with the Farm Bureau we also discussed the potential for using new technologies to deliver liquefied natural gas and/or compressed natural gas to more remote farms.

The simple fact is that ACP will bring opportunities which don't exist today. Policymakers may be interested in exploring options such as tariff modifications to support expanded distribution, increased funding for the "Ag Gas" program administered by the Department of Commerce, targeted economic development funding to support system expansion, tax-exempt funding as was done in the past to extend natural gas to the coast, etc. All of these options can now be seriously considered because the gas supply will be there to support them, assuming the ACP is constructed.

Again, thank you for the opportunity to address this issue, and as I explained, a more detailed response in being developed for Secretary Copeland and others in Governor Cooper's Administration. We look forward to sharing the non-business confidential aspects of that plan with you and your associates at your convenience.

I am committed this AM, but did get your phone message from last night and will return the call later today.

Farm Bureau President, Larry Wooten and I did have a lengthy telephone conversation yesterday afternoon. We remain committed supporters of the pipeline, but do have some caveats from recent conversations.

Certainly, we recognize this is a high-pressure line that cannot be assessed by local property owners trespassed by the pipeline easement. However, it is our understanding and belief from our research and many conversations that taps will be available to gas distributors that will increase natural gas supply and availability to consumers in our region. I understand stations have been designated along the route including Smithfield that permits access by distributors and ultimately consumers. I believe it is important for ACP Owners and support groups to identify planned distribution access locations and a projected schedule for distribution access. President Wooten and I do not believe we can wait 10 or more years to have gas availability in Eastern North Carolina: Our farmers cannot be competitive with propane vs natural gas and manufacturers or businesses will not locate here at a known energy cost disadvantage.

Our local business park has lost 2 large prospects because of the gas issue and I am aware of 2 other prospects to the north and east that would not consider Eastern North Carolina as a potential site because of the absence of gas.

Eastern North Carolina is a region in economic decline for want of necessary infrastructure to be economically competitive. Our region must have affordable energy (natural gas), broad band and road connectivity to goods, products and services in order to advance economically.

I am hopeful you can reassure us, your supporters, that natural gas will be available in a reasonable time period for distribution to consumers and economic development prospects.

We in Eastern North Carolina, consider ourselves strong advocates for protecting our environment and have carefully evaluated the benefits vs. the risk to environment and believe the risk is minimal but the benefits are great.

Although I certainly do not speak for the Governor nor his Administration, I do believe he will support allowing the professional permitting staff to perform their due diligence and ultimately make a decision that benefits the citizens and residents of our region with minimal environmental impact. It is unfair to the Governor and unreasonable as suggested by Rachel Carson Council to pressure the Governor to deny permitting without due process. I do not believe he will follow that course.

As for President Wooten and I we remain committed unless and/or until there is irrefutable evidence that contradicts our belief and understanding of the process and the need.

Thank you and please contact me if you have questions, but yes Question 5 should have a stronger, more-definitive response.
