# Report on Proposed Quadrennial Adjustment of Certain Fees and Rates

**April 1, 2025** 

Divisions of Coastal Management; Environmental Assistance and Customer Service; Energy, Mineral and Land Resources; Waste Management; and Water Resources

Pursuant to G.S. 143B-279.19

#### **Overview**

This report is submitted in accordance with General Statute § 143B-279.19. The statute directs that beginning July 1, 2025 and every four years thereafter, the Department of Environmental Quality (DEQ) shall adjust the fees and rates imposed pursuant to the following statutes: G.S. 74-54.1, G.S. 90A-42, G.S. 90A-47.4, G.S. 113A-54.2, G.S. 113A-119.1, G.S. 130A-291.1, G.S. 130A-294.1, G.S. 130A-295.8, G.S. 130A-310.9, G.S. 130A-310.39, G.S. 130A-310.76, G.S. 130A-328(b), G.S. 130A-328(c), G.S. 143-215.3D, G.S. 143-215.10G, G.S. 143-215.28A, G.S. 143-215.94C, G.S. 143-215.119, G.S. 143-215.125A, and G.S. 143B-279.13. The statute additionally directs submission of the proposed changes to various entities 90 days prior to the end of a fiscal biennium; in this case, the report is submitted for April 1, 2025. These requirements are fulfilled in the following report, which is the first report.

#### Section (a) of G.S. § 143B-279.19 reads as follows:

Beginning July 1, 2025, and every four years thereafter, the Department shall adjust the fees and rates imposed pursuant to the statutes listed in this subsection in accordance with the Consumer Price Index computed by the Bureau of Labor Statistics during the prior two bienniums. The adjustment for per transaction rates shall be rounded to the nearest dollar (\$1.00).

#### Section (c) of G.S. § 143B-279.19 reads as follows:

Notwithstanding any provision of G.S. 12-3.1 to the contrary, prior to implementing an adjustment pursuant to subsection (a) of this section the Department must, no later than 90 days prior to the end of the fiscal biennium, (i) consult with the Joint Legislative Oversight Committee on Agriculture and Natural and Economic Resources, (ii) report the proposed fee adjustments to the chairs of the Senate Appropriations Committee on Agriculture, Natural, and Economic Resources, the chairs of the House of Representatives Appropriations Committee on Agriculture and Natural and Economic Resources, and the Fiscal Research Division, and (iii) publish notice of the fees that will be in effect in the offices of the Department and on the Department's website. After making the adjustment, the Department shall notify the Revisor of Statutes, who shall adjust the amounts in statute.

### **Calculating Changes to Fees and Rates**

The relevant fees to be adjusted at their current and proposed amounts are listed below. Each fee would be adjusted by 18.6%, based on calculations supported by the Office of State Budget and Management to reflect the Consumer Price Index (CPI) from June of 2021 through June of 2025 to represent the two bienniums prior to July 1, 2025. The approximate CPI for June 2025 is projected based on the average response to the Wall Street Journal's quarterly Economic Forecasting Survey issued in January 2025. Based on existing statutory requirements, this adjustment would be applied to all fees imposed pursuant to the listed statutes, regardless of the last date of statutory change.

Given that several fees listed in G.S. § 143B-279.19.(b) were subject to statutory increases effective July 1, 2023, the Department recommends that adjustments to these fees are made based on that change rather than for the prior two bienniums, as would be required by a strict interpretation of the statute. Using the same method of calculation as above with a start date of June of 2023 and through June of 2025, these select fees would be adjusted by 5.6%.

#### Recommendations

DEQ recommends the adoption of the following fee schedule, pursuant to G.S. § 143B-279.19 and accounting for changes to fee amounts and structures effective July 1, 2023. The Department additionally recommends clarifying changes to the statute in the case where fees were adjusted by session law during the prior two bienniums. In the following fee schedule, fees increased, established, or restructured in 2023 are adjusted by 5.6%, rounded to the nearest dollar, and highlighted in blue.

The Department recommends the following clarifying change to G.S. § 143B-279.19.(a):

(a) Adjustment for Legislatively Mandated Salaries and Benefits. - Beginning July 1, 2025, and every four years thereafter, the Department shall adjust the fees and rates imposed pursuant to the statutes listed in this subsection in accordance with the Consumer Price Index computed by the Bureau of Labor Statistics during the prior two bienniums. The adjustment for per transaction rates shall be rounded to the nearest dollar-(\$1.00): (\$1.00). If a fee or rate imposed pursuant to the statutes listed in this subsection was increased, established, or substantively restructured during the prior two bienniums, the Department shall make the adjustment in accordance with the Consumer Price Index computed by the Bureau of Labor Statistics based on the effective date of the change.
